The DEDUE university degree is part of the Jean Monnet action, created in 1990 by the Commission of the European Communities, in order to develop studies on European integration in university programs.

The diploma is also aimed at all European citizens wishing to understand the European Union.

OBJECTIVES

The DEDUE aims to provide additional competence and specific legal expertise to registered students.

This is a course for students wishing to orient their further studies towards European law, or wishing to have a solid base of knowledge in this subject.

PRACTICAL ARRANGEMENTS

The course takes place over 9 months and requires a total time commitment of 100 hours.

In order to facilitate access to the course, classes take place from 5pm to 7pm or 8pm every Monday, Wednesday and Friday, from October to March.

The Diploma in European Union Law Studies consists of **three modules**, all compulsory.

There is one 3-hour written exam for each of the 3 modules. These exams are programmed at the end of the school year, outside of the exam periods reserved for Bachelor's and Master's.

EU1: INSTITUTIONAL FRAMEWORK (20 hours - 6 ECTS)

EU2: SUBSTANTIVE EUROPEAN LAW (48 hours - 15 ECTS)

- ♦ Free competition (10 hrs)
- ◆ Europe of individuals and citizens (18 hrs)
- Free movement of workers (12 hrs):
- ◆ Free movement of goods (8 hrs)

EU 3: COMMON POLICIES (32 hours - 11 ECTS)

- ◆ Economic and monetary union (4 hrs)
- ◆ Regional policy (4 hrs)
- Internal policies of the European Union (18 hrs)
- External policies of the European Union (6 hrs)

ENTRY REQUIREMENTS

REGISTRATION

Registration takes place during the month of September.

The registration fee is 400 euros
